To all the above, and to whom it may concern,

I hope you are all well during these peculiar times, whilst acting in your various state roles;

I write and serve notice upon you all, in regard to CSO changes, in the hard data presentation in CSO covid-19 series reports published from February 05th 2021 – as it has become absolutely clear that the state department of health and its state agencies are deliberately concealing critical data from the people of the nation, and that the state is thus gaining consent to treat (the jab), by gross and wilful misrepresentation;

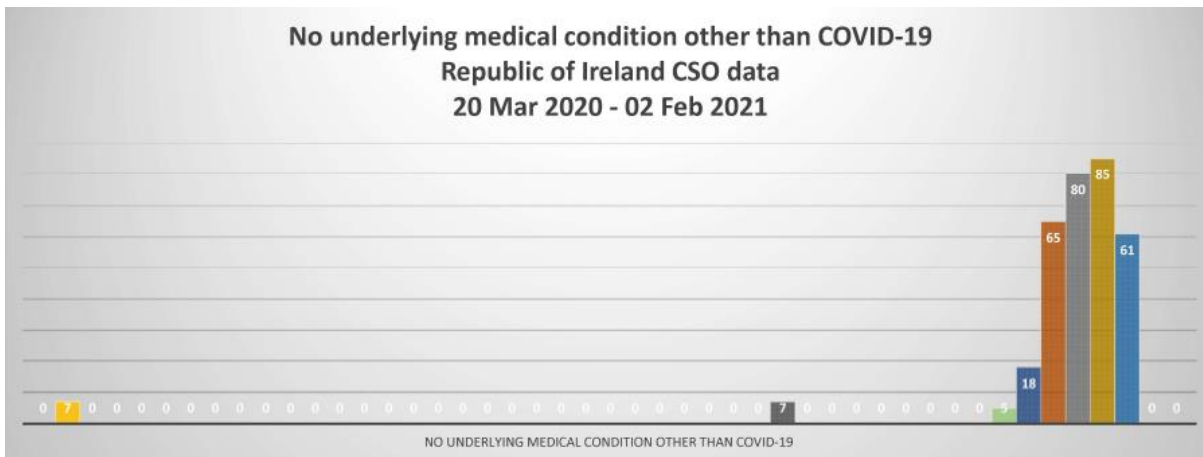

Up to the 05th February 2021 report, hard data included in collated reports, was very important and useful, as it detailed out the cumulative number of healthy people (with no underlying condition) that had died of covid-19 (14 number total through 2020, and 314 number total in 2021 to 05th February 2021); See CSO link for clarity, and I direct your attention to rows 59 to 62 therein

The stark rise in healthy deaths in January 2021 through to February 05th 2021, (314 total) tells its own tale, as the rise aligns perfectly with the roll out of the state treatment (the jab); From only the CSO data, I have generated for you all a simple bar chart to explain, see below – and same is attached with service of this national notice;



Had any national been issued this concealed information (14 number healthy deaths in 2020 out of c5m number in the 26 counties), whilst knowing that the kill rate for the untrials emergency approved Pfizer treatment is 6 out of 14,000, (this extrapolates to a kill rate of c2140 number out of c5m number in the 26 counties presuming full vaccination), would that national have consented to the state treatment (the jab)?? And add to this that the state has indemnified the manufacturer, despite the published kill rate of the adopted state treatment; Clearly the state as the nations trustee, is in breach of not only the state trust, but also the national trust, as the state is making incompetent decisions, as it did circa fifty years ago in the mother and child homes, however this time it is to the detriment of healthy irish nationals, by consent gained by gross and wilful misrepresentation, by concealing this information;

A decision was made recently by a collective within the department of health not to publish and to not continue issuing this pertinent data through the CSO out to the nation and public, since February 05th 2021 - and I would very simply like to know who these people are, and why this decision was

made??? Was this decision made to conceal, to create the misrepresented state narrative??? Only Stephen Donnelly and Tony Holohan, the state responsible persons, know these answers, as they or their state subordinates are withholding this critical information from the CSO, who cannot publish this concealed data, for the state and for the nation;

Thus take notice, the national demands below are clear and simple: I require that the state department of health and their subordinate agencies do release the following concealed information to the CSO (for scrutiny prior to publishing), and same is required to be published for nation in the normal fashion, within three days of receipt of this notice:

- 1. Provide a detailed breakout of the 314 no underlying condition covid-19 deaths in 2021 to February 05th 2021 – those healthy that died, were they given the state treatment (the jab) or not;**
- 2. Provide all the concealed and withheld data on no underlying condition covid-19 deaths, & underlying condition covid-19 deaths, from February 05th 2021 onwards – with a similar breakout pursuant to 1 above i.e. those healthy and unhealthy that died, were they given the state treatment (the jab) or not;**
- 3. Provide all the state treatment data to date (for the emergency approved RNA manipulator) to the CSO – so that they can scrutinise and publish in their normal fashion for the nation;**

The CSO have undertaken in writing, to publish the critical national data in 1 to 3 above, on receipt from the appropriate state department of health agencies, after scrutiny;

If a national default event occurs on the granted timeline, I shall be left with no alternative, than to enforce a national claim for the accruing harm, loss and damages to nationals, which will be put/laid on Frank Clarke, in his senior state judicial role, in a national court, grounded on the ongoing state breaches of the national trust, pursuant to the states failures to perform on 1 to 3 above, compelling him to answer, “is the nation and its nationals entitled to the aforementioned state concealed information”, under the many articles of Bunreacht Na hEireann breached, and if Frank answers in the affirmative, Frank shall be required and compelled to issue an interlocutory equitable national order against the state, to perform under 1 to 3 above, within an agreed set minimum timeframe, due to national urgency; And if the set national timeframe within the national order is also defaulted, and the state is in breach of any part of the national order, for contempt of a national court, the nation, shall have no alternative than to seek the national committal of the senior state legislative actor and the senior state executive actor, compelling the state by precedential lawful coercion, of these senior state actors, to perform on the national equitable order;

Additionally, on default, I shall commence by way of loss and harm accruing, and seek equitable statutory relief to compel specific state actors, within the jurisdiction of a Statutory Inferior positive law court (constituted under the courts act 1961) to comply & perform, (for offences under the various state health acts), and to compile, issue and publish this missing data, as the current failure to publish is causing state employee and state licensee harm, loss and damage to ALL those concerned acting within the Eire state trust;

And further on a national default, I shall publish this national notice, and others and I shall issue a series of criminal complaints for investigation against Stephen Donnelly and Tony Holohan, and the concealed CSO data, appears to indicate that both may have no available defence, to any of the following offenses:

And if Stephen Donnelly and Tony Holohan comply, perform and release the concealed state data and information, pursuant to the precedence set in the many CSO published reports, I undertake on behalf of the nation, to stand down this national notice honourably, but cannot undertake nor guarantee to ignore criminality in state office, if such offences may arise or have arisen;

I call herein on the national supreme court to make ready for the national relief on such a national default event, for 15th March 2021, in any court office, house, etc, as suits Frank Clarke in his senior state judicial role; The state is not required to attend, as the CSO data is prima facie evidence, of concealment from the nation and its nationals;

I, in my national capacity, and on behalf of the nation, the nationals and the national trust, consent to your future acceptance of all terms within this national notice, on such a default event;

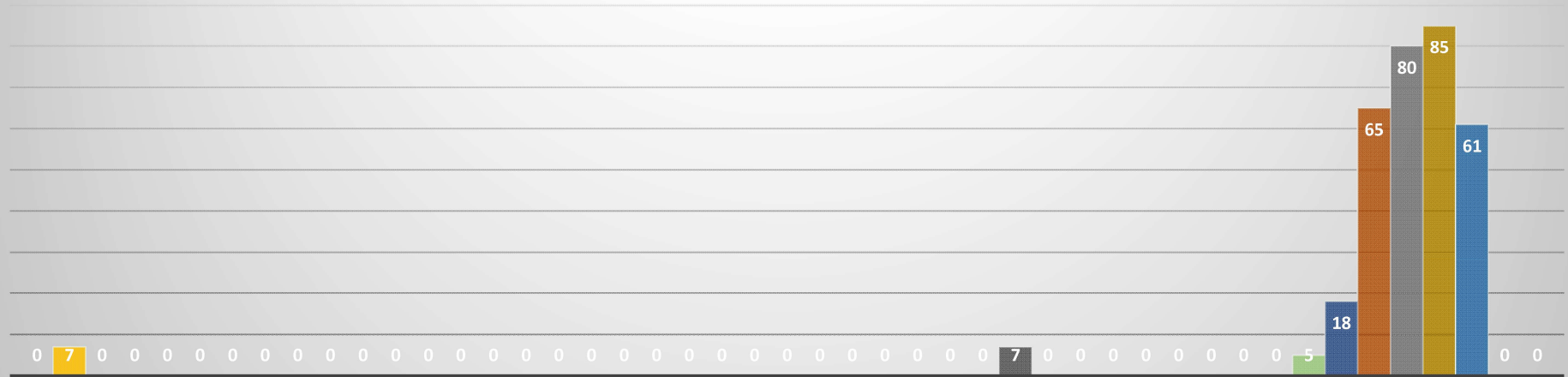
Additionally, and for the national record, I honourably clarify a number of immutable truths, prior to proceeding to lay claim on behalf of acting grantors and beneficiaries for the nation, on such a default event; Most of the following truths are obvious, even to the curious lay litigant, however they require stating, to ground this national notice on default;

IMMUTABLE CLARIFICATIONS & TRUTHS:

- CSO published data can be relied upon as prima facie authentic evidence, pursuant to the Statistics Act 1993 S16, S33, S42, S43, & S45 - *Prima facie evidence of any official statistics may be given in all legal proceedings by the production of a document purporting to contain such statistics and to be issued by the Central Statistics Office or to be signed by the Director General.*
- Eire acts as the national trustee to the Irish nation;
- Pursuant to the primary articles of Bunreacht Na hEireann - the nation is broken into 3 arms/functions, namely: Nations grantors - by blood rite & birth rite since the plebiscite, Nations Trustee - the state trust known as Eire, Nations beneficiaries - citizenry of the nation - where the ministry/department of foreign (and external affairs) is the citizenries (of the nation) only foreign agent in state; Thus I copy S Coveney herein, as a national courtesy for information purposes, at simon.coveney@oireachtas.ie;
- Eire the state, as national trustee, is comprised of 3 arms/functions, namely: Eire executor - executive, Eire trustee - legislative, Eire beneficiary - judicial/judiciary;
- Bunreacht Na hEireann, does not grant Eire, nor Eires trustee (legislative), any privilege to license the nations benefits, to the nations trustee, for consideration;
- For publication to fix a default event: This notice will be used to fix an event default, and shall be published nationally, on such a default event;
