To all the above, and to whom it may concern,

I hope you are all well during these peculiar times, whilst acting in your various state registered roles;

I write and serve national notice #4 upon you all, in regard to a national default event by the state in regard to concealed information about the state treatment being rolled out in your members premises – thus find attached to this mail, same national notice #2, also issued by way of national service upon you all, your organisation, and all your members;

As your members are allowing and partaking in the state treatment roll out (the jab), it is imperative you inform them all of the reality of the situation, as it appears that the manufacturers trial kill rate is materialising, and healthy nationals are being coerced into a state treatment and death, without the basics in fundamental data to make an informed consensual choice; Thus any state consent garnered is

void in law and fact; Based on the CSO prima facie data, healthy nationals are c150 times safer not taking the state treatment, and this national information is being withheld and wilfully concealed from the healthy and the unhealthy nationals, by the state department of health as a collective, since the outset;

Such state registered organisations, as yours, carry a great responsibility for members, and same responsibility can cause your organisation great consequences when your members allow and act against the interests of the nation and its nationals;

Thus, all of you above as served, are required forthwith, (i.e by the start of business 15<sup>th</sup> March 2021) to give notice to all your members of the following:

- This national notice #4
- The national notice #2 attached to the mail – now defaulted by the state
- That your members need to put their all insurers on notice of future actions and claims
- That garnered state consent to treat is void for the most fundamental of wants
- That state indemnities provided for you and your members, due to unlawful and defective consent, are invalid
- That state indemnities provided to manufacturers, due to unlawful and defective consent, are invalid
- That your members should not dispose of any personal assets
- That any members personal assets disposed of since February 2020 (start of the state department of health criminal concealment), are assets that may be monetised to fix a national claim;
- That your members are not exempt from any criminal complaint, charge, nor action, pursuant to details in national notice #2
- That your members do not appear to have a defence to such criminal offences and others, based on the prima facie CSO data;
- That if your members have had sight or knowledge of national notice #2 or #3, that they are required to cease and desist allowing the state treatment on their premises, until such a time as concealed and withheld national data is issued by the state to the nation through the CSO, AND until such a time as criminal offences are investigated, charged & laid, AND until such a time as valid consent can be attained by providing nationals with the pertinent and relevant data to make informed consensual choices;

- That if the NHI as a collective, abdicate this national responsibility, that you as served, nor your members individually can never rely upon a Nuremburg type defence to any future claim, charge or death;

I, in my national capacity, and on behalf of the nation, the nationals and the national trust, consent to your future acceptance of all terms within this national notice, on such a default event by the nhi on the 15<sup>th</sup> March 2021, as the default terms within national notice #2 have come into full force and effect for all state registered entities;

This national notice #4 will be published, as relevant and pertinent information for all nationals;

This national notice is issued without ill will, without vexation, and without frivolity;
