To all the above, and to whom it may concern,

You are all advised that as a collective you have failed to perform and have defaulted on behalf of the state, the national notice #2 dated 08<sup>th</sup> March 2021, as served on respective state actors on 09<sup>th</sup> March 2021; Thank you to those that acknowledged receipt of same service;

It is clear that as no served party bothered to update this national prior to midnight on Friday the 12<sup>th</sup> March 2021, that in some way the state is attempting to ignore, bury its head in the sand, remain in denial, deny its own cognitive dissonance, or to call a bluff;

So let me honourable, clear and concise, that due to the states national default – agreed consensual national terms and conditions now come into full force and effect, such as the following:

1. Registered entities within the state, have been informed that the states indemnities no longer apply due to concealment and withholding of data from nationals, therefore rendering any

semblance of fundamental consent valid, thus lawfully void, for state treatment (the jab); The national notice in default was issued with same information, as prima facie evidence of state default; CSO prima facie evidence of concealment was included;

2. Respective national notices to respective registered entities within the state, and the defaulted national notice #2, and this default notice #5, are in the process of being published;
3. Prima facie evidence packs are in the process of being bundled for media distribution;
4. Criminal complaints for investigation will be filled against S Donnelly and T Holohan shall commence when filed and prima facie evidence will be handed over to the nations protectors, an garda siochana;
5. Etc

I now honourably call on the state supreme court registrar, to convene forthwith, a national supreme court pursuant to articles 63 inclusive;

- I shall act in my national capacity pursuant to articles 1 and 2,
- And ONLY the state can act in its state capacity pursuant to articles 4 to 8,
- The national claim will be grounded in the national court, upon articles 63 inclusive, pursuant to the national and state constitutions of 1937, and prima facie evidence will be furnished of national defaults, CSO undertakings, CSO data, breaches of national trust, causing harm, loss and damage to nationals, concealment, misrepresentation, etc;
- Frank Clarke in his state role will act as the bridge between the superior nation, its national, and the nations servant state (eire);
- The national claim shall be immediately adjourned for better days;
- And a national article 40 (40.3 etc), will move the national court, and frank shall be required to answer the specific three questions, on behalf of the state, pursuant the defaulted national notice#2, in the performance of his state judicial duty pursuant to article 35, regarding whether the nation and its nationals are entitled to the state concealed data;
- And frank shall issue on foot of the grounded prima facie evidence, a national injunction upon the state, compelling the state to perform within an agreed set minimum timeframe, due to the urgency of the matter;
- This national injunction shall set out specific default terms, and shall be signed and sealed by frank and I, and shall be witnessed by 3 competent national jurats pursuant to article 1 and 2, on behalf of the nation, its nationals and its national court, prior to service on the senior actors in the state legislative and state executive functions;
